Bylaws permit:

- **Co-chairs of a Precinct to be appointed by the vacancy committee upon any vacancy.**
- **Appointees voted upon at the next RCC mtg.**
- **At the next Caucus the registered Republican attendees confirm the Co-Chair appointees by vote**

Duties of the Precinct Co-Chair



- **Provide relevant information to registered Republican in your Precinct various times each year via many different methods.**
- **Attend RCC meetings monthly**
- **Co-lead the Caucus in the Spring of even numbered years**
- **Be a public representative of the RCC at County functions**
- **Support Republicans Candidates at County & City Elections**

Organizing the Precinct Caucus

A. Caucus Location

- 1. Find a public or private meeting hall for 30+ people**
- 2. Ask for free usage if possible, arrange for key, lighting, heat, tables and chairs**

B. Post the Sign provided to you by RCC Secretary ,

- 1. Outdoors at the meeting site as specified by State Rules.**

C. Notify registered voters in your Precinct Re: the meeting

- 1. Telephone tree calling;**
- 2. Word of mouth**
- 3. Club announcements**
- 4. Social Media**

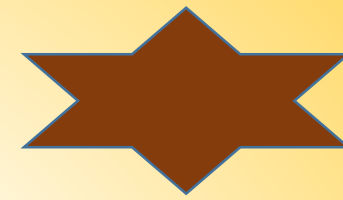
Setting up the Meeting Room

1. Setting up the meeting room one hour before the doors open...

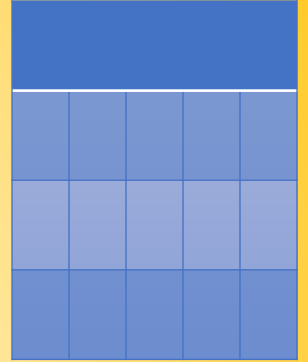
- a. Registration tables**
- b. Other tables – for hand outs, raffle tickets, posters**
- c. Chairs, rows or half circles, etc.**
- d. Coffee, Water table**



SET UP cont.



1. Head Table for Precinct Co-Chairs
2. Flags
3. Chalk board, computer screen, or large easel paper for viewing materials
4. Voting slips, writing utensils, tally sheets
6. Help!!! For Clean up



Facilitating the Meeting

- Calling the meeting to order
- Ground rules: unlocked doors, restrooms, time limits, coffee, water
- Prayer - Pledge
- Election of Caucus Co-chairs
- Secretary is a volunteer to keep notes of meeting speakers, votes, resolutions, etc.
- Tally committee of 3 people
- Meet the registered Republicans with a very quick go around
- Co-Chairs are permitted to rally the participants; encourage attendees to become Delegate; promote candidates you support; and permit members of the meeting to promote candidates that they support
 - Prospective Delegates should sign up as they get registered at the door

Primary Business of the Caucus

- Primary business is to elect Delegates to the County Assembly how to nominate & vote
 - Prospective Delegates should sign up as they get registered at the door
 - Additional Delegates can be nominated during the meeting from the floor but have to be present
 - Vote for a specific number of delegates as prescribed by your Precinct instructions
 - Part two is to elect seconds to the County Assembly, who may be seated if one or more of the elected Delegates cannot attend on the Assembly date.

Meet the Candidates

- Time limits set
- Letters may be read by a representative, friend, or Co-Chairs if a candidate cannot attend your Caucus



Offering and Accepting Resolutions

- **Resolutions – presented by and rewritten to fit the Assembly Format**
 - **Correctly written with clear description and meaning**
 - **Voted on by the registered Republicans at the Caucus and passed to the RCC the following day for the County Assembly**

Moving to the County Assembly

- a. Follow up with delegates getting them to Attend the Assembly
- b. Managing your delegation at the Assembly
- c. The Vote
- d. Nominations to the State Assemblies
- e. Keeping the Delegation informed after the Assemblies
